
OTHER LEGACY GIFTS

In addition to your bequest, there are other ways you can remember Edmundite Missions.

RETIREMENT PLAN ASSETS

Naming Edmundite Missions as the sole, partial, or contingent beneficiary of a retirement plan, such as a 401(k), 403(b), Individual Retirement Account (IRA), Keogh or pension plan, is a tax-efficient and easy way to make a gift.

Naming Edmundite Missions as a beneficiary of a retirement account and leaving other assets to heirs may be a more efficient way to fulfill financial and charitable goals. Your estate receives a charitable tax deduction for the value of the gift, and Edmundite Missions is not taxed on the income arising from the plan.

LIFE INSURANCE POLICY

You can use life insurance to make a gift by naming Edmundite Missions as the beneficiary of your policy. When you pass away, Edmundite Missions receives the proceeds as the beneficiary, and your estate receives a charitable tax deduction. Or you can name Edmundite Missions as owner and beneficiary of a paid-up policy.

OTHER BENEFICIARY DESIGNATIONS

You can also name Edmundite Missions as the beneficiary of other financial accounts. When you pass away, Edmundite Missions receives the proceeds as the beneficiary, and your estate receives a charitable tax deduction.

GIFTS BY WILL (BEQUESTS)

Name Edmundite Missions as a beneficiary of your will or trust by:

- Giving a specific dollar amount or percentage of your estate.
- Leaving a particular asset — stocks, bonds, mutual funds, real estate, artwork, or other property.
- Naming Edmundite Missions as a residual beneficiary, so that the organization receives the remainder of your estate after all other bequests have been satisfied and final taxes paid.

If you already have a will, you can add Edmundite Missions to it by simply executing an amendment.
